**Important Notes :** The total number of section of the school shall be restricted to 23 (as per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws. The Maths lab is looking like temporary arrangement. Equipment/ materials are not properly organized. The school is directed to arrange all the equipment/ materials properly and follow the SoP given by the Board

The building safety certificate with office seal of issuing authority shown to RC member is not uploaded by the school in the link. Hence the school is directed to upload the same in mandatory public disclosure link.

The school is required to comply with the observation / suggestion of the RC members i.e., i) ramp at the entrance is not safe as only one rod is there ii) Girl's urinals do not have partition doors iii) Concentrated acids are kept in open and live specimens are presented in lab iv) Proper stock register need to be maintained in Maths lab and books need to be issued in library to students on regular basis for home v) Salary is not as per the norms. Variation could be seen in the salary paid and in the appointment letter. The suggestions to be taken care of.

The school must ensure provision for CWSN such as ramp at the entrance, ramp / lift to access upper floor and separate toilets for girls and boys on every floor with proper infrastructural facilities in accordance with the provisions laid down in RPWD Act.

The school shall conduct training of its teachers with CoE Pune within 3 months and submit the compliance.

The school is advised to follow the SoPs issued by the Board in respect of labs, library and sports facilities.

The school shall get all the mandatory certificates renewed periodically.

The school is directed not to remove the mandatory disclosure section from its website and the videography link of the inspection /infrastructure from YouTube.
